

DAWLEY HAMLETS PARISH COUNCIL

Minutes of the Full Council Meeting

Held on Wednesday 18th March 2026 at 7:00pm
at Aqueduct Primary Academy

25/139. Welcome

The Chair welcomed everyone to the meeting.

He informed the meeting that Cllr Stefan Heighway had been automatically disqualified under Section 85 of the Local Government Act 1972. Cllr Heighway last attended a meeting on 17 September 2025, and no qualifying attendance or approved reason for absence occurred within the required six-month period. A Notice of Casual Vacancy was issued today and published in accordance with statutory requirements.

25/140. Apologies for Absence

Apologies were received from Cllrs K Barnes, R Mehta and I Preece.

25/141. Declarations of Interest and Dispensation Requests

Cllr Hannington – Great Dawley Town Council; Lawley & Overdale Parish Council
Chair – Dawley Hamlets Local Nature Reserve

25/142. Public Session

One member of the public spoke regarding Item 10 on the agenda (Easter Eggs for Aqueduct Primary Academy).

He expressed a preference for funds to be spent on life-skills activities rather than Easter eggs.

The Council responded that Dawley Hamlets Parish Council already supports Aqueduct Primary Academy (the parish's only school) in other ways, including contributing towards the annual pantomime visit and, this year, Crucial Crew for Year 6 pupils. Crucial Crew provides essential life-skills and safety education. Councillors also noted that without the Council's contribution, some pupils may not receive an Easter egg at all.

The Chair asked whether councillors supported the purchase; the overwhelming response was in favour.

25/143. Minutes

The minutes of the meeting held on 18th February 2026 were approved.

25/144. Play Areas

The Chair introduced Richard Foden, Telford & Wrekin Council Play & Recreation Infrastructure Officer.

Richard explained that there are 118 play areas across the borough, and he is responsible for ensuring they are maintained and meet safety standards. Idverde carries out weekly risk assessments and reports issues to him; he also receives reports via MyTelford.

He noted that play areas are expensive to maintain and expenditure is driven by insurance and safety requirements.

Richard circulated copies of the Shirefields Way Play Area safety report and thanked the Council for its pledge of £4,657.50 towards carrying out recommended improvements, agreed at the February meeting.

Richard left the meeting at 7:22pm.

25/145. Councillors' Reports

Cllr Hannington:

- Concerns about frogs being squashed at Horsehay Pool have reduced as this is not happening as frequently.
- Working with residents of Horsehay Court regarding maintenance issues where the management company does not appear to be fulfilling its responsibilities.
- Reports of increased ASB on the bridle path from Bridge Road towards the Traveller's Joy Public House.

The Clerk will add this location to CAT enforcement patrols.

Borough Cllr Andy Burford:

- Ongoing issues with the management company responsible for Stonebridge Close; T&WC is often unfairly blamed by residents for lack of maintenance.
- Continued parking issues in many areas including Gittens Drive; the problem is borough-wide and difficult to resolve.
- Some landscaping and tree issues caused by recent storms are still awaiting resolution.

Chair:

- Attended a CAT maintenance work-plan meeting yesterday.
- A good amount of time has been spent on matters relating to the disqualification of Cllr Heighway and the resulting casual vacancy process.

25/146. Community Action Team (CAT)

The updated Neighbourhood Enforcement February Action Plan and the new March Plan were circulated ahead of the meeting on 2nd March. Majestic Way patrols were added as requested by Cllr Barnes at the last meeting.

The Chair and Clerk met with Aaron England, James Taylor and Bill Stewart (DHPC Maintenance Operative) yesterday at Granville House, Donnington, to update the workplan so that the Council has an up-to-date, detailed document going into the next financial year.

Cllr Hannington reported the recent absence of plastic bags in the bins around Horsehay Pool; she will monitor the situation and report via MyTelford if necessary.

25/147. Local Nature Reserves (LNRs)

DHLNR – Chair:

Three volunteer sessions run by Rick Shaw (funded by the Friends group) have now finished clearing areas and trees to improve access and encourage plants such as heathers to grow.

25/148. Easter Eggs

The Council considered the provision of Easter eggs for Aqueduct Primary Academy (250 required by 27 March).

RESOLVED: The Chair confirmed he would fund the Easter eggs from his allowance.

25/149. Annual Parish Meeting

The Clerk explained the reason for the Annual Parish Meeting.

It was agreed to hold the meeting at 7:00pm on Wednesday 15th April 2026 at Horsehay Village Hall, immediately before the April Ordinary Council meeting.

Local community groups will be invited, as in previous years, along with James Taylor (the new T&WC Public Realm Officer replacing Dave Ottley).
